

RESIDENTIAL 10-YEAR LIMITED WARRANTY CERTIFICATE

LIMITED WARRANTY

WaterFurnace International, Inc. (WFI) warrants the WaterFurnace heat pump unit identified by the serial number on this Limited Warranty Certificate ("Certificate") and all accessories purchased and installed with this unit (separately and collectively, "Product") to be free from defects in material or workmanship under normal use and maintenance, when properly installed in an owner-occupied single-family dwelling, for the Warranty Period defined in the chart below. This limited warranty is subject to all the provisions, conditions, limitations and exclusions stated on this Certificate.

REGISTRATION AND TRANSFER

This limited warranty extends only to the original owner of the Product and any subsequent owner of the Product and is subject to the terms and conditions herein stated. Registration is not required and this limited warranty transfers automatically. However, registration may ensure that the original and transfer owner(s) receive the latest acceptable Warranty Start Date. - The Warranty Start Date shall be the date of registration of the Product (see REGISTRATION AND TRANSFER).
- The Warranty Start Date of an unregistered Product shall be the actual start-up date of the heat pump. It will be the owner's responsibility to provide documentation of the actual start-up date in a form acceptable to WFI. Required documentation may include but will not be limited to a report of a final inspection prior to occupancy, a dealer invoice, work tickets, etc.
- If the actual start-up date cannot be verified, the Warranty Start Date shall be the date of original shipment of the Product from WFI as shown on its shipping document.

CLAIMS AND REMEDIES

- If the Product fails due to a defect covered under the terms of this Certificate within the applicable Warranty Period, WFI, at its option, will provide a new, rebuilt or replacement part.
 - You must cooperate with the Dealer in making and processing your claim. Cooperation may include without being limited to granting reasonable access for removal and return of defective parts upon request.
 - You will not be charged for the new or replacement part under the terms of this Certificate.
 - Applicable labor and/or refrigerant allowances will be in accordance with published WFI rate schedules corresponding to the original date of shipment of the Product from WFI.
 - Any rebuilt or replacement part provided by WFI is warranted under this Certificate for the balance of the original Warranty Period.
- To make a claim under this Certificate, you must notify a WaterFurnace Dealer within sixty (60) days of the Product failure on which your claim is based. You will be asked to give a detailed, explanation of the problem and to follow other instructions that the Dealer may give you.

- Actual costs incurred for any and all labor or materials, including without being limited to refrigerant materials, in excess of the published labor allowance and/or refrigerant material allowance specified in this Certificate.
- Costs of normal maintenance, including without being limited to cleaning and/or replacement of filters.
- Claims or damages, including without being limited to damages to the Product, arising out of or related to the use of parts not included in the original sale of the Product, whether or not supplied, approved or designated by WFI and whether or not necessary for use of the Product.
- Product relocated after original installation and non-replacement parts or accessories added after the original installation.
- 5. Product failures or performance issues arising from or related to improper ordering or installation of Product or related components, including without being limited to improper selection of the size of Product or related components, improper duct and/or distribution system, and improper installation or choice of open or closed loop system.
- Product failure or performance issues arising from or related to misapplications, improper voltage, blown fuses, improper operation, or improper maintenance or repair.
- Damages arising from or related to misuse, abuse, unauthorized alteration, flood, wind, fire, lightning, accidents, corrosive environments, acts of God, or other conditions beyond the control of WFI.

- Damages arising from or related to improper conditioning of the water supplied to the heat exchangers, fouling of the water supply or HVAC system by foreign material, or like causes.
- Electricity or fuel costs, including without being limited to increases or unrealized savings in electricity
 or fuel costs, for any reason whatsoever.

- 11. Product from which the WFI serial number has been removed.
- 12. Products sold outside the United States or Canada
